


#### Installation Instructions:

- a mounting location for the unit on a flat surface. Place the se, flat side down, on the surface.
- four holes in the base to mark the drill locations for ng. It may be necessary to remove the light head from the y turning the base handle counter-clockwise until the head removed. For reference, the mounting holes are 50mm x square, center-to-center.
- Ir 5.5mm diameter through holes through the mounting . Align the base with the mounting holes and place the M5 hex head bolts through the base and the holes. Place a washer on the other end of the bolt and tighten with the M5 nut. Repeat for the other three bolts.
- 4. Place the light head back in the base and turn the handle clock wise until the head is captured. Position the light in the appropriate direction and fully tighten using the handle.
