

Installation and Operation Instructions 400 Series R65 LED Beacon

The 400 Series R65 LED Beacon features 12 powerful LED's arranged to produce a 360° flash pattern, with a flash rate of 125FPM for maximum visibility. Now with additional features including multiple flash patterns and rotate functionality (non ECE R65). This Beacon is suitable for applications where the UK lighting regulation Chapter 8 is a requirement. Combining the solid state, maintenance free and long life nature of LED technology with a proven tough housing design. This ECCO Group Europe, UK produced beacon is designed to maximise resilience to excessive vibration and increase the life of the product.

Wire:

RED: = +VE (12-30V DC)

BLACK: = 0V

BLUE: = Connect permanently to GND (Black) for Simulated Rotate

YELLOW: = (Pattern Select and Synchronisation) – Connect to GND to cycle through the flash patterns. The patterns have Phase A and B. Connect the Yellow with both Phase A and the unit will synchronise up to 4 Beacons. Connect beacons with Phase A and B and the units will flash asynchronous
